Scenario-Based Training

Now Available

- 1. Training completion was originally intended to be linked to Provider Relief Fund (PRF) attestation, but that is no longer the case.
- 2. To obtain a completion certificate, providers must achieve an 80% passing score.
- 3. Training is not mandatory but is highly recommended by CMS.
- 4. Many state surveyors are taking this course, and CMS will be able to track the participants.

These trainings will have financial incentives of approximately \$6,000 per nursing home for participation through funding from Department of Health and Human Services (CARES Act Provider Relief Funds). Trainings are slated to begin in September 2020. Participating nursing homes will receive federal funding to support the implementation and adoption of quality improvement practices and measures.

Training Goals

- 1. Prevent COVID-19 from entering nursing homes via staff, visitors and patients.
- 2. Prevent the spread of the virus among patients, staff and visitors once it enters a nursing home.
- 3. Provide care and treatment for patients who test positive for COVID-19.
- 4. Protect staff from infection and provide safety measures to help staff build confidence in their work, feel safe from infection and keep working at nursing homes.
- 5. Ensure patients who are infected with COVID-19 can safely receive visitors.
