(**Helena, Mont.**) – On April 25th Mountain-Pacific Quality Health will celebrate 45 years of improving health care quality and value in the states we serve.

We first opened our doors in Helena, Montana, in 1973; since then we have broadened our reach to include Wyoming, Alaska, Hawaii and the U.S. Pacific Territories of Guam, American Samoa and the Commonwealth of the Northern Mariana Islands. Headquartered in Helena, Mountain-Pacific has offices in Alaska, Hawaii, Wyoming and Guam.

Mountain-Pacific is one of 14 Quality Innovation Network-Quality Improvement Organizations (QIN-QIOs) in the United States that partners with health care providers, practitioners, stakeholders and patients on a variety of quality improvement initiatives to achieve better care, better population health and lower health care costs. Mountain-Pacific also provides Medicaid utilization and pharmacy review and management services for the Montana Department of Public Health and Human Services.

"Mountain-Pacific has partnered within our communities to provide solutions for better health for more than four decades," said Sara Medley, Mountain-Pacific's CEO. "We are honored to have such an important role in improving care, improving the health of the populations we serve and reducing the costs of health care.
